

## PROPOSED AMENDMENTS MAY CONVENTION 2021



The following amendments to our Bylaws and Standing Rules have been proposed for action by the membership at our 2021 Spring convention.

#### **#1 New Section for Article XI**

Section F Changes in the Bylaws and Standing Rules of DKG VT necessitated by amendments to the DKG International Constitution and/or Standing Rules shall be made by the DKG VT Rules Committee with the State President as an ex-officious member and then reported to members as soon as possible on our web site and in the next issue of our State Newsletter.

**Rationale:** Provides a timely process for updating our Bylaws and Standing Rules to be consistent with International DKG's governing documents and for distributing the updated Bylaws and Standing Rules to the membership.

#### #2 Bylaws Revision

Article VIII Section Revision C1f(5) conduct an induction service at the spring convention in even numbered years upon request of at least one chapter.

Rationale: Provides more flexibility for induction of new members at spring convention.

#### **#3 Standing Rules Revision**

2.1 DKG Vermont may induct members at the spring convention in even-numbered years, upon request of at least one chapter, unless authorized by the Executive Board to do otherwise. (4-28-12) **Rationale**: *Please see #2 above* 

#### #4 Bylaws Revision Article IVB3

All dues and fees shall be collected by the chapter treasurer. State and International dues and fees shall be forwarded to the Vermont state treasurer. International dues shall be forwarded to DKG International.

Rationale: To be consistent with DKG International's governing documents.

#### **#5 Standing Rules Replacement 11.6**

Each fiscal year a fee of \$1.00 per member shall be assessed for scholarships as required by International Standing Rule 4.2. Chapters who maintain a scholarship fund shall allocate 80% of the scholarship fee to the chapter scholarship fund and 20% to DKG Vermont scholarship funds. Chapters who do not maintain a scholarship fund shall allocate 100% of the scholarship fee to DKG Vermont for its scholarship funds.

DKG Vermont shall allocate 50% of the scholarship fees it receives to the Memorial Scholarship Fund and 50% to the Enrichment Grant Fund. In years in which the Memorial Scholarship Fund is already fully funded, 100% of the annual scholarship fees received will be allocated to the Enrichment Grant Fund. (+27-19)-Rationale: To be consistent with DKG International's governing document.

#### #6 Bylaws Replacement Article VII 6

Electronic Meetings Business of DKG Vermont and all of the bodies governed by its Bylaws may be transacted electronically as long as all members are able to hear each other simultaneously and can actively participate in the meeting.

Rationale: Permits all meetings at both the state and chapter levels to be conducted electronically.



# Proposed Amendments

May Convention 2021 (cont)



#### **#7 Bylaws Revision Article IX Section C Publications 1**.

A state newsletter, DKG Vermont News, shall be published at regular intervals at the discretion of the DKG Vermont Executive Board and sent to all state members.

Standing Rules <u>Deletion</u> 10.2 DKG Vermont shall publish up to three newsletters annually. (4-27-13) **Rationale**: The proposed revision and deletion together confirm that the Executive Board determines the publication schedule of the state newsletter.

#### #8 New Bylaw Section for Article VI Section E8

Electronic (non-secret) voting for officers and other elected personnel may be permitted when the election is held at an electronic meeting.

Rationale: To permit electronic voting during an electronic meeting.

# **SCHOLARSHIP NEWS**

Are you considering pursuing a graduate program to reach your educational goals or perhaps needing that workshop bridging virtual learning? The Covid 19 pandemic has changed the "in school classroom model." Our teachers have had to revamp, adjust, and create new remote and hybrid learning for their students. Most districts now contribute towards professional development, but with unexpected pandemic budget expenses, this may be reduced unless it's part of the negotiated contracts. In our own DKG past history, professional development was not well funded and varied from districts. This led to the establishment of a scholarship fund where in 1946 Alpha Lambda State, along with other New England and New York chapters, contributed towards a scholarship of \$1,000 to Miss Damina Eugeno from the Philippines to attain a Master's degree from Mt. Holyoke College. This State scholarship has since evolved into Alpha Lambda State Memorial Scholarship. It will soon be known as DKG Vermont Memorial Scholarship to align with International word changes.



# SCHOLARSHIP NEWS (cont)

The word "Memorial" was added in honoring a past member who made significant contributions to the Society. Some of these past named Memorial ladies were: Catherine Nulty, Dr. Bertha M. Terrill, Catherine Wilcox, Mary Jane Simpson, Gertrude Sinclair, and Alice Howe. The last memorial Scholarship was awarded to Deborah Tower (Zeta) in 1997! Madge Boardman is our next named Memorial Scholarship yet to be awarded.

This Memorial scholarship has been established to encourage members to pursue educational opportunities for advanced certification degree work beyond a Bachelor's level (I.e., Masters, Doctoral, Specialist Program, and National Board Certification)

In 2017 my committee reviewed the wording and requirements of our scholarships and found our criteria and eligibility are in line with other state forms. Previously you needed to be a member for 5 years. This was changed to 3years. We deleted the old requirement of being a chair of a chapter committee or officer at the chapter/and or state level. Instead, we inserted "Importance is attached to active participation at the chapter and or state level." \*This scholarship awards \$2,000 \*Three years membership \*No deadline

If you have the older copy in your files, you certainly can use them in requesting this scholarship as it is just the name change not the requirement criteria. I will be posting the new form on our state web page and sending your chapter presidents a packet with the new forms. www.alphalambdavt.weebly.com

Our most popular and widely used scholarship is the Educational Enrichment Grant. It was first called "Summer Study Grant" and was awarded in 1953 to Cecilia Murphy for \$100. Since then, 52 grants have been awarded. The most recent was 2019 to Lian Brehm (Delta).

It supports participation in seminars, conferences, educational travel, research, Elderhostel, chapter service projects, para educator licensure, work designed to contribute to professional development as educators/para educators, or in a setting advocating and supporting education. \*no set amount of money \*no deadline Please take note DKG International made changes at their Austin Convention that now impacts how we fund our State scholarships and grants. As long as each local chapter maintains their own chapter level scholarship, DKG Vermont will only receive 20 cents as the 80 cents per member will now remain at the local chapter. This lesser amount of 20 cents isn't sufficient to fund/replenish our state scholarships/ grants. We participated in several Zoom meetings this fall and early winter to discuss how to comply with International's new changes and be in compliance.

Thank you, Marilyn Grunewald, Mary Ann Riggie, Ann Bannister, Jill Wilkens, Donna Stone, Barb O'Neil, Carol Barbagallo, and Marcia Barron for your insightful ideas. In discussing with Helen Popovich, International Parliamentarian, Mary Ann Riggie was successful on how to best fund scholarships at the state level. Helen advised since there are no constitutional rules limiting what a state organization such as DKG Vermont may include in its yearly state budget, a separate line item for State Scholarships could solve the funding issue and keep us in compliance with International constitutional new rules.

Currently \$15 per active member goes to fund the state budget and operating expenses. At our Feb. Winter Board Meeting it was suggested that the Executive Board consider adding an extra line item for Scholarships in each future budget. Since our Memorial Scholarships are fully funded, the standing rule 11.6 states the amount would go into the Educational Enrichment Grant until such time that the Memorial Scholarships are awarded and need to be replenished, then it would be divided 50/50 between both of them.

A motion will be presented and voted upon by our members at our Spring State Convention in April. They will need to understand why it is necessary to adopt this new proposal. Hopefully my report gives you the background information necessary in requesting the changes.
