Thoughts from the President, March 2019 You've Come a Long Way, Baby!!

Dear DKG sisters.

Truly you receive more than you give; that is how I feel about my two years serving as president of Vermont DKG. While Delta Kappa Gamma Society International goes through its Constitutional changes, we members are part of a still vibrant organization which is adapting to societal and educational workplace changes. International is dealing with the same loss of members that we are, the same lack of young professional participation, and the same need to find a way to keep our group alive and growing.

As I was reflecting on a theme for my biennium, the issue of keeping DKG alive and growing gnawed at me. Without active members, how will DKG survive? During the leadership training and the plane flight home, I decided on the theme, "Re-E-vitalize through membership and action". My goal has been to keep Vermont DKG moving forward by encouraging new leadership while energizing members already serving as chapter leaders who do the real work of the society. I also have supported improved communication and the recruitment and induction of new and younger members.

Looking back at the first mini-newsletter explaining the theme, I used some E-words: Enrich, Encourage, Energize, Email, Excite, Exchange, Educate, Examine, and Exercise. These thoughts ended up guiding my efforts. To me the most progress has been made in communication.

Mini- newsletters were emailed by the fabulous "tech assistants" from each chapter and snail mailed to those members without computer access.

Emails to the executive board and chapter presidents keep our lines of communication open and effective. When a local leader needs help and sends an email, it is my responsibility to respond in a timely manner.

Attendance at chapter meetings allowed me to meet and share "spiritual fellowship" with members from all over the state. I heard some wonderful speakers on a variety of topics, and I observed chapters' unique styles and practices.

Facing my incompetence in tech, I forced myself and encouraged others to learn how to use "Zoom", an application for online group meetings. The nominations committee used it to develop a slate for the elections in April. The Rules committee was able to handle the huge job of amendments with the executive board's input by using Zoom. The February executive board meeting was able to be held with some members at-

tending in Rutland and some "zooming" in!

With the two large newsletters and the mini-newsletters; communication to the members was monthly, at the least. We also receive the U.S Forum newsletter periodically, thanks to Cheryl Hooker.

However much that has been accomplished, there is more that could be done. Your input into how I could improve or how the state executive board could do more to assist chapters is not only needed, it is requested.

She will turn us on to some of the most powerful TED Talks and tell a few stories of the amazing thought leaders who she is talking to every week through Ever Widening Circles.

Rules Committee Report Respectfully submitted, Mary Ann Riggie

In January Executive Board members held a work session viaZoom to review proposed amendments to our state *Bylaws* and *Standing Rules*. Additions and corrections were made as the group examined a draft document of the proposed amendments. Some of the changes were "copy edits" to prepare the document for publication to the membership. Some of the changes clarified language in Section 11, "Scholarships" in our *Standing Rules*. All of these changes have been incorporated into the document. Members present recognized that "Music Fund" is not addressed in either *Bylaws* or *Standing Rules*. President Marcia appointed an *ad hoc* committee to investigate the history of the "Music Fund". This committee has since communicated with several members. As a result language clarifying the purpose and use of the music fund has now been added to the proposed amendments document.

In the course of developing draft amendments in order to comply with actions taken at last summer's International Convention, we discovered and addressed other needs in our state documents. All of these changes have now been incorporated into the proposed amendments document.

As the next step in the process, on behalf of the Rules Committee, I offer the following motion: That the Executive Board approve the proposed amendments to our state *Bylaws* and *Standing Rules* and approve the distribution of the proposed amendments to the membership in preparation for discussion and action at our 2019 Spring Convention.

I hope that Executive Board members can find opportunities to discuss the proposed amendments with local chapter members prior to Spring Convention.

NEW [Section 3 Executive Board]

- 3.3 The following process shall be used for the approval of minutes: The state president shall appoint a three (3) member review/approval committee at the beginning of each business meeting.
- The recording secretary shall
 - (a) take minutes at business meetings
 - (b) submit a draft of the minutes to the state president and state parliamentarian as soon as possible, but no later than 14 days after the meeting
 - (c) edit the minutes and submit them again to the president prior to submitting them to the minutes review/approval committee
 - (d) submit the minutes to the minutes review/approval committee with deadline for response;
 - (e) return approved minutes to the president; if corrections are needed the process is repeated;
 - (f) finalize formatting and obtain president's signature for the approved minutes;
 - sign with pen and ink (adjacent to the president's signature) the final version, initial, insert date of approval, scan, and keep a copy for the secretary's file;
 - (h) mail approved minutes with original signatures to the State Historian for placement in DKG Vermont's permanent files;
 - (i) distribute approved minutes of business meetings (executive board and state convention) with scanned signature page to executive board members within 45 days of meeting and make printed copies of state convention minutes available at next state convention. [Enter adoption date]

NEW Section 6 Membership

- 6.5 An active member shall be a woman who is or has been employed (paid) as a professional educator at the time of her election.
- 6.6 A collegiate member may participate in the activities of the Society except holding office. A collegiate member may serve as parliamentarian since the position of parliamentarian is not an elected office.
- 6.7 A member may submit a recommendation for membership to any chapter.

13.1 DKG Vermont Rules Committee is authorized to correct article and section designations, punctuation, capitalization, and cross references and to make such other technical and conforming changes to the State Bylaws and Standing Rules documents as may be necessary to reflect the intent of the membership when the membership duly adopts amendments to the documents.
